Permits Closed Out:

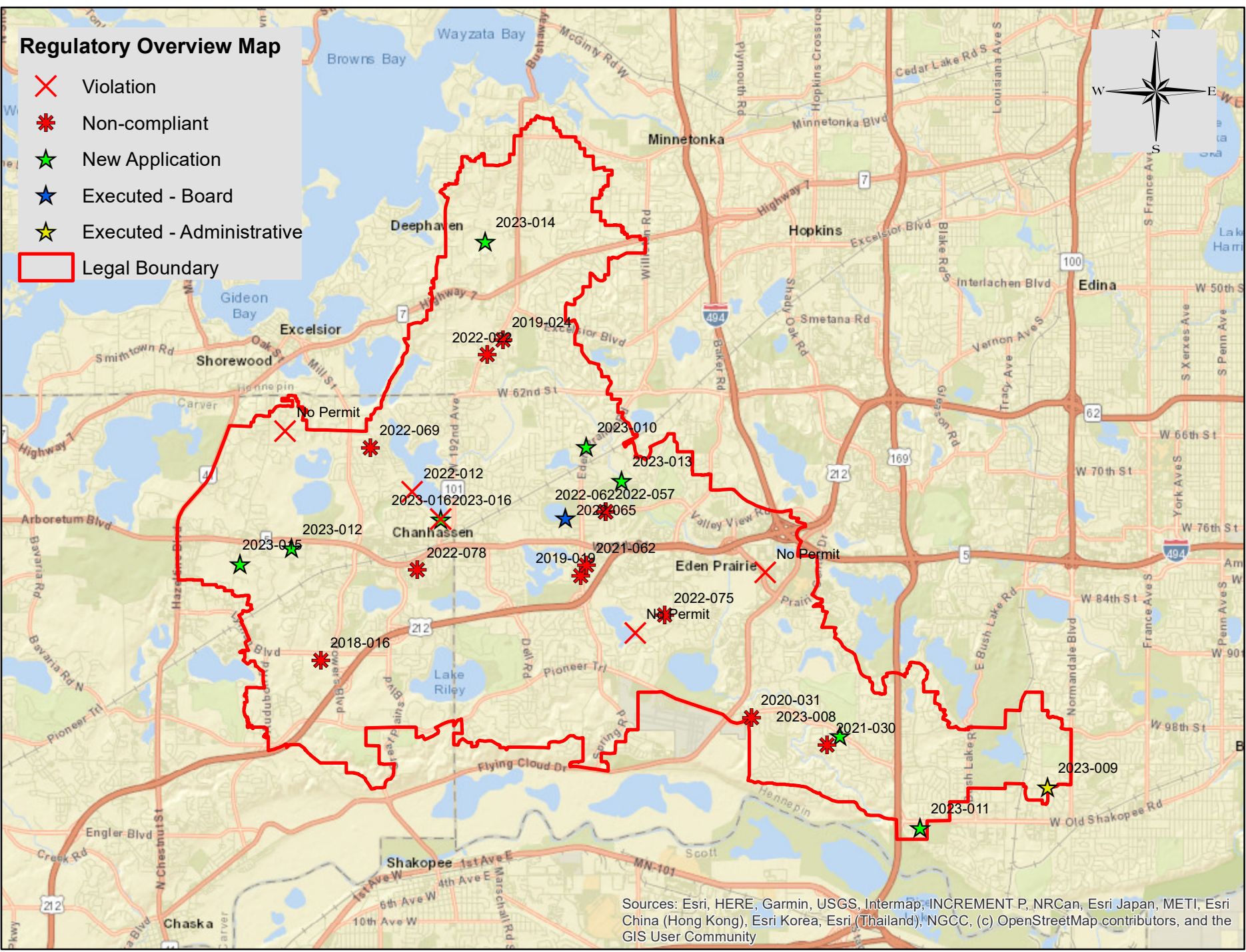
No permits have been closed out.

Inspections:

Inspections were carried out on 25 permitted sites within the district. Of these sites, 13 required corrective action on the part of the permittee and none were found to be non-compliant. Issues consisted mainly of perimeter controls having been damaged or displaced by snow or snow removal equipment. 2 sites also had sediment issues due to snow mixed with soil being stockpiled outside of perimeter controls. Property owners and EPSC representatives were notified of the corrective actions required via email.

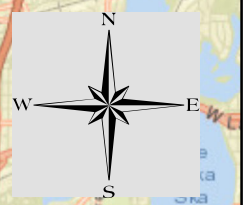
